Pledge to the Flag: Niagara County Federation of Conservation Clubs February 2005 Meeting held on the 28th. Called to order at 7:00 p.m. by President John Butcher at the 4-H Bldg., Lockport, New York with the Pledge to the Flag.

Minutes: Motion made from the floor by Chris Schotz to accept minutes, 2nd by Dale Dunkelberger, carried.

Roll call of clubs and directors: Sheets were passed around and signed by the delegates.

Financial Report: Motion to accept the financial report presented by Gordon Botting Sr. was made by Gerry Bennett and seconded by 2nd by Keith Hetrick, carded.

- Spring Shoot at North Forest: Bryan Meahl President of North Forest Rod and Gun passed around a poster for the spring shoot. The proceeds will benefit the Niagara County Federation Youth Program, Shooting Sports and DEC Camp. The location will be at North Forest. The venue is 100 birds, 50 sporting clays, 25 trap and 25

skeet. Break a target and get a ticket. For each ticket you get they have a Chinese auction. Drop your ticket in the bird bucket. Each person that gets involved in the shoot will get 25 tickets. This event is family oriented. Children from 12 to 17 are welcome to shoot for \$15.00 dollars as opposed for \$25.00 for an adult. The juniors will be sponsored with free shells. It will be on Saturday, April 23, 2005. Shooting will be from 9:00 a.m. to dusk. Breakfast is 8:00 a.m.. It will consist of biscuits, sausage, gravy and coffee for \$3.00. Lunch will consist of hotdogs, hamburgs, picnic salad and soda for \$5.00. Games of chance will be a 50-50 split, Chinese Auction and a gun raffle at \$5.00 a ticket. One of the sponsors will be Beretta with their new 2005 offerings. Speak with their factory representatives. If you are interested, you will have a chance to test fire their trap, skeet and sporting clays shotguns on the various fields North Forest has to offer. They will take your drivers license and require that you only shoot factory ammo. Beretta is also sponsoring the gun raffle of the day with a Beretta Model 391. All the shells you need will be for sale at the best price. Bring along your friends and family even if they don't want to shoot. North Forest is a pretty little place just to walk around and enjoy the outdoors in a less than formal atmosphere.

- Sports Fishing: Paul Jackson

- Paul Jackson reported that there will be a Lake Ontario "State of the Lake" meeting on Monday, March 14, 2005, 7 - 10:00 p.m. at the Cornell Cooperative Extension Building, 4487 Lake Avenue, Lockport, New York.

- Paul Jackson read a resolution from Erie County:

- Whereas sport fishing is a two billion-dollar business in New York State;

- Whereas the majority of these diverse world class sports fisheries are dependent on the New York State fish hatchery stocking program;

- Whereas the annual stocking requirements are one million pounds of fish for the waters of New York State;

- Whereas the New York State fish stocking programs derive at least a five to one return on money invested;

- Whereas many of the 12 existing hatcheries are in dire need of repairs and updating if New York State is to maintain the present fish stocking levels;

- THEREFORE BE IT RESOLVED that Governor and the State Legislature dedicate no less than 22 million dollars from the state general fund for the necessary updates and repairs on the aforementioned hatcheries.

- Bill reminded everyone that to take advantage of the service they are offering to sportsmen on firearms related issues. Ken Mathison is working for them full-time as their lobbyist in Albany. If you go to their website www.SCOPEny.org you can download a PDF file of 42 bills they are reviewing. Bill passed around a copy of this 12-page report.

- Bill reported he contacted Scope President Ken Mathison and NRA Director Budd Schroeder about the Niagara County Pistol Permit holder who was burglarized and had his pistol stolen and permit suspended for six months by a recent court decision of Niagara County Court Judge Peter L. Broderick, Sr. Both men are against any law requiring mandatory storage of firearms. Ken Mathison thought this gentleman should have been more careful where and how he stored his firearms. Budd Schroeder mentioned that under New York State Laws a pistol permit is a privilege and requiring this gentleman to have a safe to store his guns in could fall under judicial discretion.
